Rick Belcher, Board Director

Rick Belcher has been a member of Sharonview for over 30 years and a volunteer for SFCU since 2005. He spent 3 years on the Supervisory Committee and has been a Board member since 2008. He currently serves on the ALCO and Governance Committees. In addition, he has served in the past on the Executive, Technology, Membership, and Enterprise Risk committees. Belcher has a BSBA from East Carolina and retired from INVISTA (formerly known as KoSa, Hoechst Celanese Corp) in 2025.



Larry McAdams, Board Director

Larry McAdams has served on the Sharonview Board of Director's since 1998. He currently serves as the Chair of the Compensation Committee and serves on the ALCO Committee. Prior to his retirement from KEMET Corporation in 2012, he held the position of Chief Human Resources Officer. Larry was instrumental in KEMET becoming a SEG of Sharonview Federal Credit Union in 1988.

Larry graduated with a BA degree from Clemson University and attended the University of South Carolina School of Law. Over the years, he has served on numerous non-profit boards including the United Way of Greenville County; YMCA of Greenville Metro Board; Salvation Army Advisory Board, Workforce Investment Board of Greenville County, Urban League of Columbus, GA; and the American Red Cross, Rock Hill, SC Chapter. He currently is the Chair of the Staff Parish Relations Committee at Mauldin Methodist Church.

The Nominating Committee has completed the application review process of candidates for the two open Board of Directors positions (each to serve a three-year term commencing on April 23, 2026). Members of the Nominating Committee appointed to consider all eligible applicants and select the candidates were Nominating Committee Chair **Jeffrey Meekins**, **Lynn MacLeod**, and **Roy Fahl**. The committee nominated the following two candidates whose names are presented: **Larry McAdams** and **Rick Belcher**. There will be no election conducted by ballot and no nominations from the floor when there is only one nominee for each position to be filled. Nominations may be made for vacancies by petition signed by 500 members of Sharonview Federal Credit Union who are over the age of 18. The nominee(s) must also be at least 18 years of age.

The petition application form (which includes an authorization release authorizing a background and credit check) may be obtained by emailing **Nominations@sharonview.org**. To be effective, nominee(s) must complete the petition application form (including the authorization form and the required member signatures as noted above) and must include a signed certificate with the nomination petition stating that they are agreeable to nomination and will serve if elected to office. Nominee(s) are also required to include a recent candidate photo, a brief statement of qualifications and biography of 250 words or less.
