## Don Lathrop

Member of Sharonview for over 20 years. Service within Sharonview began in 2009 and includes serving on the Supervisory Committee, Membership Development Committee, Technology Committee, ALCO, and as an Associate Director. The committee nominated the following three candidates whose names are presented: Don Lathrop, Larry McAdams, and Rick Belcher. There will be no election conducted by ballot and no nominations from the floor when there is only one nominee for each position to be filled.

The time period for nominations to be made by qualified petition was open between March 3, 2023 to March 31, 2023. As there were no applications submitted by petition during this time period, the three open positions will be filled as selected by the Nominating Committee and will be formally announced at the 2023 Annual Meeting to be held on Thursday, May 18, 2023, at 6:00 p.m. (EST) at: Sharonview Federal Credit Union, 1955 Sharonview Way, Indian Land, SC 29707.
