The committee nominated the following four candidates whose names are presented: **Phil Ridolfi**, **Ernie Taylor**, **Roy Fahl** and **Jessica Dahle**. There will be no election conducted by ballot and no nominations from the floor when there is only one nominee for each position to be filled.

The time period for nominations to be made by qualified petition was open between February 2, 2022 to March 19, 2022. As there were no applications submitted by petition during this time period, the four open positions will be filled as selected by the Nominating Committee and will be formally announced at the 2022 Annual Meeting to be held on Thursday, April 28, 2022, at 6:00 p.m. (EST) at: Sharonview Federal Credit Union, 1955 Sharonview Way, Indian Land, SC 29707.
